To apply for an ARDMS exam, you must qualify through one prerequisite pathway.

All listed items must be met and completed prior to application submission.

¹CLINICAL EXPERIENCE -- PATHWAYS 1 and 3A ONLY

Obtain one of two ways: Employment or Education

Employment-based: Minimum: 12 months and 1,680 hours in ultrasound/vascular clinical setting.
or

Education-based: Successful completion of formal, full-time ultrasound/vascular program. Minimum: 12 months and 1,680 total program hours, including appropriate clinical and didactic hours, and requires clinical internship/externship to complete the program. If the program exceeds 12 months, Applicant must successfully complete the program in its entirety.

- Clinical settings must be hospitals, clinics, or private practices only.
- Volunteer, unpaid, barter, instructorship, or veterinarian experience is not accepted.
- Education and clinical experience timeframes cannot overlap.
- Full-time is defined as 35 hours per week, minimum 48 weeks per year (1,680 hours minimum). Part-time experience is prorated accordingly.
- Non-diagnostic ultrasound/vascular experience (e.g., 3D/4D scans) does not count toward ARDMS clinical experience requirements.

PATHWAY REQUIREMENTS

SPI Requirement - Early Entry Pathway

- Physics transcript must show applicant name and school name. Course title must specifically include “Physics,” “Physical Principles,” and/or “Instrumentation.” Unofficial transcripts accepted. Grade of C or above required.
- Number-only grades must include a letter grade equivalent key on the transcript.
- Handwritten transcript information will not be accepted.
- CME certificate: minimum 12 ARDMS-accepted credits from a physics seminar, review course, or correspondence course. Credits must be earned within two years prior to application.
- CV form is not required for the SPI examination.
- If the SPI is your first ARDMS exam and you can qualify under a full prerequisite pathway, applying under that pathway is recommended — future application processing will be faster.

Pathway 1

- Must be a single program: e.g. sonography, registered technologist, RN, PT, OT, respiratory therapist
- A two-year allied health education program that is patientcare related is defined as (1) 24 full-time consecutive calendar months or (2) 60 semester credits or (3) 84 quarter credits (4) and requiring a clinical internship/externship to complete the program. Credit hours are based on U.S. equivalency in a post-secondary institution. The program or school must be authorized by an accrediting agency to award semester or quarter credits and the type of credits granted must be reflected on the transcript. Transcripts reflecting clock hours must be converted to credit hours.
- Transcript must be official; must state specific number of credits and indicate quarter or semester system; must include graduation information.
- If using DMS/CVT program for education, 12 additional months clinical experience is required outside the program.
- Clinical experience letter must meet ARDMS requirements — see [Sample Letters](#) for Employer or Program Completion sample letters.
- CV form required for each specialty area applied for — see [sample forms](#).

Pathway 2 - Graduate

- ARDMS does not allow for retro accreditation.
- Program director letter is valid for one year from graduation date. If applying after that window, new documentation and a current CV form are required.
- The CV form is not required if the application is submitted and received within one year after successful completion of the program. After one year, a signed CV form for each specialty area is required.

Pathway 2 - Student

- Paperless Application Program for eligible students. [Learn more](#), then contact your [Program Director](#).
- Students applying before graduation through the Paperless Prerequisite 2 application process must successfully complete their program to retain any passed exam results obtained through this process.
- ARDMS will rescind any passed exam results and/or certification(s) obtained through this process if the program is not successfully completed.
- The CV form via this program is valid for 60 days prior to graduation and 1 year from that date of exam eligibility (not 1 year from graduation date).

Pathway 3B

- Students may apply up to one year before completion, provided 12 months of full-time clinical experience within the program is completed at time of application.
- If the program is also CAAHEP/USDOE/CMA-accredited and the student has graduated, apply under Pathway 2 instead.
- CV form is not required if applying within one year prior to program completion and 12 months clinical is met. Otherwise, CV form required for each specialty area.
- Student letter valid through expected graduation date. After graduation, a graduate letter and current CV form are required.

IMPORTANT NOTES FOR ALL PATHWAYS

Before you apply

- All requirements must be met and documentation submitted by your application deadline.
- The name on all supporting documentation must match your application name exactly. If it does not, submit legal documentation of the name change (e.g. marriage or divorce certificate).
- Documents in a language other than English must include a notarized English translation.
- All submitted documents become the property of Inteleos and will not be returned.
- Official transcripts may be opened for upload into your MY ARDMS or MY APCA portal.
- Eligibility is not determined by phone, fax, or email.
- Prerequisites are subject to change. You must meet the requirements in effect at the time of application.
- Inteleos, ARDMS, and APCA may request from you or others information concerning matters relevant to your eligibility for certification and certification status.

Please be advised that your initial approved application may be subject to a post-approval audit, which may require us to request additional documentation or clarification to ensure the integrity of our certification standards. If then found ineligible during this final review, your application may be canceled with a partial refund offered, and any scheduled exam appointments would then be automatically canceled.

EDUCATION — FOREIGN EQUIVALENCY

Applies to: Pathways 1, 3A, 3B, and SPI Requirement

- All foreign degrees or transcripts must be accompanied by a formal course-by-course evaluation from a Foreign Education Transcript Evaluation Organization.
- This evaluation must confirm that the applicant has met the education requirements for the corresponding pathway under which they are applying.
